

Park and Field Rentals Information Guide

Overview

- Proof of 501c3 is required to receive a non-profit rate.
- A 10 percent increase (minimum of \$5) will be added to all rentals by non-residents or primarily non-resident groups/teams. Proof of Parker residency (such as a team roster) may be required.
- The daily rate will apply when a rental is eight (8) hours or more.
 - Rental timeframes must include set-up, tear-down *and* the amount of time the park venue must be closed to the public. Fees are assessed *per venue*.
- Amenities such as added trash barrels, *power*, access to water and lighting are only available upon request.
 - While electric outlets are available at most shelters, *electricity is not guaranteed*. Park crews work to assure outlets are on; however, many outside factors are beyond our control, such as vandalism, breakers tripping, power outages. *Should you need guaranteed electricity*, please consider using a generator. A generator waiver must be agreed to at checkout.
- Any rental for commercial use, including commercial photography/videography, must be approved by the Town and will be charged the for-profit rates listed below.

Rental Request Details and Fees

Dec. 1: Rental requests open for January through June of the following year to the public. *Equestrian rental requests can be made for the entire following year on Dec. 1*

March 1: Rental requests open for July through December of the current year to the public.

Park Shelters	<ul style="list-style-type: none"> • Open for use <i>March 1 – Dec. 31</i> each year • A minimum of two (2) hours is required per rental • Rental request must be made 72 hours in advance
Equestrian Rentals <i>Rentals open on Dec. 1 for the entire following year.</i>	<ul style="list-style-type: none"> • Open for use <i>March 1 – Dec. 31</i> each year • A minimum of two (2) hours is required per rental • Practice arena comes with the Rose Taylor arena rental • The first prep of the horse arenas (drag only) is included in the rental fee <ul style="list-style-type: none"> ○ Additional drag preps may be requested for \$50/prep

Downtown Parks: O'Brien and Discovery Park Rental Overview and Fees

- The Town may limit the number of events/rentals hosted in downtown parks.
- The [Town of Parker Noise Ordinance](#) (Ord. 5.59.2 §6, 2021) applies to all renters. *Community events approved by the Town may be exempted from the limitations on time and decibel levels as part of the review and approval process for a Community Event Permit.*

O'Brien Park

- Any rental that requires exclusive use of the O'Brien parking lot will be required to pay the Full Park Rental fee.
 - Full park rentals are not permitted during the months that H2O'Brien Pool is open for use (generally Memorial Day to Labor Day). Some exceptions, as granted by the Town, do exist.

Discovery Park

- Any renter requiring theatrical or audio assistance, must coordinate with the Town of Parker Cultural Department for staffing availability and fees.



- Any rental that requires exclusive use of the lawn *and* band shell will be required to pay the Full Park Rental fee.

Special Event, Disc Golf and Trail Rental Overview and Fees

- A roster or listing of registered participants must be received one (1) week prior to the rental.
- A final roster or participation report must be received within 72 hours of the event to confirm total numbers. The renter will be charged based on the total number of participants at the event.
- Payment must be complete within 30 days upon final invoice.

Westcreek Disc Golf Course

- Only one (1) rental per month will be allowed.
 - Rental requests are based on first-come, first-served historical reference and flexibility of rental.
 - The rental permit includes exclusive use of the shelter.
- Closures will be advertised on Parker Parks and Recreation social media and a generic sign placed at the park.

Trail Events (5/10K, Cross Country Meets, Bike Races, etc.)

- Races will be advertised on Facebook and the Event Calendar to alert other trail users.
- Trails remain open to the public, regardless of the event.

Add-On Fees

The following fees will be charged for rentals requiring any additional needs from Parks and Recreation staff. Cost estimates are provided upon booking your reservation. However, final costs will be determined by the amount of time and resources spent throughout the rental.

Add-On	Cost	Notes
Set Bases (Ball Fields)	\$10	Bases are set for team practices <i>upon request only</i> .
Ball Field Prep (line and drag)	\$35/field per prep	If additional preps require overtime from staff, overtime will be charged at \$50/hour per staff.
Ball Field Prep (drag only)	\$18/field per prep	If additional preps require overtime from staff, overtime will be charged at \$50/hour per staff.
Lights	\$35/location	One-time fee per rental, per location. Lights are available at Salisbury Fields, O'Brien Field, Rose Taylor Arena, Tennis Courts, Pickleball Courts. <i>There is no charge for light use on the Pickleball or Tennis Courts. Light curfew is 10 p.m.</i>
Water	\$50	One-time fee to turn on the tap. Most parks have water available for filling weights, watering animals, etc. Access to drinking water is limited.
Additional Trash cans and removal (3 are included)	\$50	Fee includes all additional cans required for the size of the event. <i>Renters may request Parks staff to remove trash during the event for a fee of \$50/hour, per staff required.</i> Rentals that produce an abnormal amount of trash, debris or cleanup will be charged \$50/hour per staff.
Staff Overtime	\$50/hour	Estimates will be provided prior to the rental; final overtime charges will be billed after the event.
Displacement Fees	TBD	Displacement fees are charged back to the renter to cover the cost of additional materials, staff hours, and administrative work (schedule changes, park closures, staff coordination, etc.). Estimates will be provided prior to the rental.
Damage	TBD	Any damage to a park area or equipment caused by the renter will be charged back to their account. The renter will be responsible for the total cost of damages.
Annual Photography/Videography Permit	TBD	Please contact jvollertsen@parkeronline.org for requests.
Community Event Permit	TBD	Rentals requiring additional assistance from Parks and Recreation staff or those that exceed 100 participants may require a Community Event Permit. Read more about Community Event Requirements here.
